BE IT ORDAINED by the Slidell City Council that Chapter 2. Administration, Article I. In General, Section 2-2.2. Certain city and parish officials to be notified upon adoption of annexation ordinances., Sub-parts (a), (b), and (c), of the Code of Ordinances of the City of Slidell are hereby amended as follows:

Delete Sub-parts (a), (b), and (c) of Section 2-2.2. in their entirety and replace with the following language:

- (a) Within ten (10) days after each ordinance which annexes property into the City of Slidell is signed by the mayor, the Clerk of the Slidell City Council shall provide a copy of said annexation ordinance to the following:
 - (1) The Director of Planning
 - (2) The Chief of Police
 - (3) The Director of Finance
 - (4) Office of the Superintendent of Public Works
 - (5) Office of the Superintendent of Utilities
 - (6) Each utility which pays a franchise tax to the City of Slidell
- (b) Within ten (10) days after each ordinance which annexes property into the City of Slidell is signed by the mayor,
 the Clerk of the Slidell City Council shall provide a copy of
 said annexation ordinance which shall be certified true by the Clerk
 of the Slidell City Council to the following:
 - (1) The Assessor of St. Tammany Parish
 - (2) The Registrar of Voters of St. Tammany Parish
 - (3) The Justice Department of the United States

(c) Within ten (10) days after each ordinance which annexes property into the City of Slidell is signed by the mayor, the Clerk of the Slidell City Council shall provide a copy of said annexation ordinance which shall be certified true by the Clerk of the Slidell City Council to the Clerk of Court of St. Tammany Parish with a request that said annexation ordinance be recorded by the Clerk of Court of St. Tammany Parish.

(d) The Clerk of the Slidell City Council shall file a certificate in the archives of the Slidell City Council which shall certify the date, to whom, and how the said annexation ordinance was provided to the officials referenced in sub-parts (b) and (c) hereinabove.
