22 BE IT ORDAINED by the Slidell City Council that Chapter 2.
23 Administration, Article I. In General, Section 2-2.2. Certain city
24 and parish officials to be notified upon adoption of annexation
25 ordinances., Sub-parts (a), (b), and (c), of the Code of Ordinances
26 of the City of Slidell are hereby amended as follows:

30 Delete Sub-parts (a), (b), and (c) of Section 2-2.2. in
31 their entirety and replace with the following language:

35 nexes property into the City of Slidell is signed by the mayor,

37 said annexation ordinance to the following:

57 said annexation ordinance which shall be certified true by the Clerk

11 (c) Within ten (10) days after each ordinance which an-
12 nexes property into the City of Slidell is signed by the mayor,
13 the Clerk of the Slidell City Council shall provide a copy of

15 of the Slidell City Council to the Clerk of Court of St. Tammany
16 Parish with a request that said annexation ordinance be recorded
17 by the Clerk of Court of St. Tammany Parish.

19 (d) The Clerk of the Slidell City Council shall file a
20 certificate in the archives of the Slidell City Council which shall
21 certify the date, to whom, and how the said annexation ordinance
22 was provided to the officials referenced in sub-parts (b) and (c)
23 hereinabove.
