43 organizations as defined by Chapter 2 Louisiana Revised Statute 12
44 and having 3/4 of its membership residing inside St. Tammany Parish,
45 Schools, and School Sponsored organizations shall be allowed usage
46 free of charge.

49 Page 1, Lines 73 and 75: After the word "buildings" in
50 line 73, delete the words "must provide" and replace with the words
51 may be required, and on line 75 after the word "use," insert the
52 words to provide.


55 Page 2, Lines 13 and 15: Delete the sentence, "Exceptions
56 to this requirement are given only by the Mayor or the Chief of Staff."
57 and replace with the following language: Factors to be considered
58 in deciding whether issuance is required, shall include, but not

60 possible danger to participants and guests.

63 Page 4, Line 64: Add the following sentence: A senior
