45 City of Slidell are hereby repealed and reenacted as follows:

47 **Sec. 17-11. Annual license tax.**

49 There is hereby levied an occupational license tax for the

51 year 1988 and for each subsequent year, upon each person pursuing

53 and conducting any business, trade, calling, profession, or voca-

55 tion, within the corporate limits of the City of Slidell, subject

57 to license under the Louisiana Constitution and laws of this state.

60 **Sec. 17-12. Adoption of state laws.**

62 The amount of license tax levied in each case is hereby fixed,
63
64 determined, and ordained to be the same as that fixed, levied, and
65
66 collectible by the governing authority under, and shall be granted
67
68 in accordance with the provisions of Louisiana Revised Statutes,

70 Title 47, Sections 341 through 363, inclusive and as hereafter
71
72 amended, and all other applicable laws, all of which for all pur-

74 poses of this ordinance are made a part hereof by reference as if

Sec. 17-13. Peddlers.

All peddlers, defined by Louisiana Revised Statutes 33:4833, et seq shall obtain a license costing one hundred dollars.

Sec. 17-14. Effective date.

This ordinance shall become effective January 1, 1988.


Sec. 17-15. Repealer clause.

All other ordinances or parts of ordinances, except Chapter 12 1/2 PEDDLERS*, in conflict herewith are repealed in their entirety as of the date this ordinance becomes effective.


Sec. 17-16. Severability clause.

If any provision of this ordinance, or the application thereof is held invalid, such invalidity shall not affect other provisions or applications of this ordinance which can be given effect without the invalid provisions or applications, of this ordinance are hereby declared severable.
