18 An ordinance annexing and zoning from Parish Rural to  
19 C-4 Highway Commercial approximately five (5) acres located north  
20 of Gause Boulevard behind Northshore Regional Medical Hospital,  
21 petitioned by N.M.E. Hospitals, Inc.; and authorizing Mayor  
22 Salvatore A. Caruso, or his authorized representative, to execute  
23 the annexation agreement, a contract between the City of Slidell  
24 and N.M.E. Hospitals, Inc., attached hereto and made a part hereof.

27 WHEREAS, the Slidell City Council has received a petition  
28  
29 from N.M.E. Hospitals, Inc. requesting annexation and zoning from  
30  
31 Parish Rural to C-4 Highway Commercial approximately five (5) acres  
32  
33 located north of Gause Boulevard behind Northshore Regional Medical  
34  
35 Hospital; and  
36

37 WHEREAS, said petition also includes a request to execute  
38  
39 the annexation agreement, a contract between the City of Slidell and  
40  
41 N.M.E. Hospitals, Inc., attached hereto and made a part hereof; and  
42

43 WHEREAS, the Slidell Planning and Zoning Commission approved  
44  
45 such annexation and zoning with the condition that the attached  
46  
47 contract be executed in conjunction with City Council approval of  
48  
49 said annexation and zoning.

51 NOW, THEREFORE, BE IT ORDAINED by the Slidell City Council  
52  
53 that the following described property be annexed into the corporate  
54  
55 limits of the City of Slidell, Councilmanic District E, and zoned  
56  
57 from Parish Rural to C-4 Highway Commercial:  
58

59 All that certain parcel of land being situated in Section 1,  
60 Township 9 South, Range 14 East, St. Tammany Parish, Louisiana,  
61 being more fully described as follows: From the Section corner  
62 common to Sections 1 and 12, Township 9 South, Range 14 East and  
63 Sections 6 and 7, Township 9 South, Range 15 East, thence along  
64 the Section line common to said Sections 1 and 6 North 1320.00  
65 feet; thence South 89 degrees, 11 minutes West 1331.33 feet;  
66 thence South 89 degrees, 09 minutes 26 seconds West 305.43 feet to  
67 the Point of Beginning.  
68

69 Thence continue South 89 degrees, 09 minutes, 26 seconds West  
70 along the Northern boundary of Small's Subdivision a distance of  
71 743.20 feet; thence North 01 degree, 21 minutes, 18 seconds West  
72 292.51 feet; thence North 89 degrees, 09 minutes, 26 seconds East  
73 746.05 feet; thence South 00 degrees, 47 minutes, 48 seconds East  
74 292.50 feet to the Point of Beginning.

76 Containing in all 5.00 acres of land, more or less.

13 or his authorized representative, is hereby authorized to execute  
14 the annexation agreement, a contract between the City of Slidell
