28 Sub-part (1): Line 35: After the word "organizations",
29 delete the language, "incorporated as nonprofit corporations in
30 accordance with Chapter 2 of Title 12 of Louisiana Revised
31 Statutes".

34 Sub-part (1) (c): Line 65: Delete all language after
35 the first sentence.

38 Sub-part (1): Add the following sub-sections:

41 (d) Fees - Non Profit Organizations in accordance
42 with Chapter 2 of Title 12 of the Louisiana
43 Revised Statutes: Fees shall be \$10.00.

46 (e) Fees - Private Organizations other than charitable,
47 religious or public service: Fees shall be
48 \$50.00 per day.

51 (f) Fees - Private Organizations holding special
52 events, the proceeds of which will be used solely
53 for charitable, religious or public service purposes:
54 Fees shall be waived.


57 (g) Fees - Charitable, religious, or fraternal organi-


