33 Sub-part (a)(2), of the Code of Ordinances of the City of  
34 Slidell, is hereby amended as follows:

37 Line 43: Delete the period ( . ) and add the  
38 following language: , and have a set back of  
39 one and one-half (1-1/2) times the height of  
40 the tower from any residential lot line.
