26 NOW THEREFORE BE IT ORDAINED that the Slidell City
27 Council, in legal session convened, does hereby expand its rules
28 and procedures and establishes a new subsection 6.7 in the Code of
29 Ordinances of the City of Slidell Appendix B Chapter 6. Agenda as

37 6.7 Executive Session
38

40 The Slidell City Council may hold an executive session
41 upon an affirmative vote of two-thirds (2/3) of its members
42 present, taken at an open meeting for which a public notice has
43 been given. The executive session shall be limited to matters
44 allowed by law. In no case shall any binding action be taken in an
45 executive session. A request for an executive session must be
46 made by a Council member or an official of the City of Slidell
47 with a Council member's concurrence. A written and signed
48 statement shall be submitted to the Council through its Council
49 Administrator or Council Chairman/President, in the format attached
50 hereto and made a part thereof, and shall serve as the agenda for
51 the executive session. In the event one (1) or more members of
52 the Council calls for a point of order in executive session,
53 the President of the Council shall rule whether the matter is
54 pertinent to the executive session agenda. If the Council member
