ORDINANCE NO. 2163

An amendment to Item No. 87-10-1225, an ordinance amending Ordinance No. 2134 Chapter 9 Crimes, Section 9-79 Unnecessary Noise, of the City of Slidell.

BE IT ORDAINED by the Slidell City Council that Ordinance No. 2134, Section 9-79 Unnecessary Noise Subsection (C) 1 Maximum Permissible Sound Levels of the Code of Ordinances of the City Slidell is hereby amended as follows:

Page 40, Lines 24 through 62, delete all language and replace with the following:

2. PROCEDURE AND MEASUREMENTS: Sound level measurements shall be made with a properly calibrated sound level meter using the A weighted network in accordance and conforming with the noise measurement standards based on the referenced sound pressure, promulgated by the American National Standard Institute and Testing Procedures (ANSI). The sound level measurement shall be taken at the point on the receiving property which is closest to the source of sound on the producing property and where practical not less than five (5') feet above ground level, but in no event less than three (3') feet above ground. A minimum of three (3) readings shall be taken at two (2) minute intervals. The sound level shall be the average of these readings. In the case of two (2) family or multifamily dwellings, the sound level shall be measured within an adjacent intra-building dwelling. When a noise source can be identified and its noise measured in more than one (1) land use category, the limits of the more restrictive use shall apply at the boundary and within the most restrictive land use category.

(C) PROHIBITIONS:

1. MAXIMUM PERMISSIBLE SOUND LEVELS BY RECEIVING LAND USE:

No person shall operate or cause to be operated on private property, any source of sound in such a manner as to create a sound level which exceeds the limits as established in the following table in accordance with the time of day and zoning applicable to the receiving land use category as follows:
