An ordinance annexing three (3) parcels of land donated by the Salmen Corporation to expand the right-of-way of Spartan Drive to 120 feet east of Ponchartrain Drive, by the City of Slidell.

BE IT ORDAINED by the Slidell City Council in legal session convened that the City of Slidell does hereby annex parcels A, B, and C into Councilmanic District B of the City of Slidell as follows:

S. Highway 11; thence N26 degrees 37'00"E along said easterly right of way line a distance of 60.00' to the point of beginning.

Thence from the point of beginning measure N89 degrees 30'00"E a distance of 417.11'; thence S00 degrees 00'00"E a distance of 15.00'; thence S 89 degrees 30'00"W a distance of 333.66'; thence N80 degrees 17'29"W a distance of 84.66' to the point of beginning.

PARCEL C

Thence from the point of beginning measure N00 degrees 00'00"W a distance of 45.00'; thence N89 degrees 30'00"E a distance of 1377.91'; thence S44 degrees 45'00"E a distance of 62.82'; thence S89 degrees 30'00"W a distance of 1422.14' to the point of beginning.
