16 to Veterans Park.

18 Whereas, the Slidell City Council has received a
19 request from the St. Tammany Parish Sheriff's Office to
20 rename Salmen Park as Veterans Park; and

24 Whereas, it would become a permanent place to honor
25 St. Tammany Parish Veterans, and

28 Whereas, the St. Tammany Parish Sheriff's Office
29 would like to hold a dedication of the park on May 21, 1988,
30 Armed Services Day.

34 Now, Therefore Be It Ordained by the Slidell City
35 Council that the park known as Salmen Park is hereby renamed
36 Veterans' Park with its location more full described as
37
38 follows:

42 That certain tract or parcel of ground, together with
43 all buildings and improvements hereon, designated as
44 Square 37 and part of Square 34 in the Fractional
45 Northwest one-quarter ($\frac{1}{4}$) of Section 15, Township 9
46 South, Range 14 east, in the City of Slidell, Parish of
47 St. Tammany, State of Louisiana, which said squares have
48 been sometimes known and referred to as situated in the
49 Robert Addition to said City of Slidell, together with a
50 strip of ground 60 feet in width forming an extension of
51 Bryan street immediately North of and adjacent to said
52 square 37; all in accordance with Survey No. 5313 by J.
53 V. Burkes, C. E., dated February 19, 1968, a copy of said
54 survey being hereto annexed and made part hereof. Said
55 tract of ground is bounded North by the northern line
56 of section 15, Township 9 South, Range 14 East, East by
57 third Street, South by Cleveland Avenue and West by
58 Second Street.

60 Being the same property acquired by Fritchie Bros., Inc.
61 from Salmen Brick & Lumber Company Ltd. per deed dated
62 April 1, 1939 and recorded in COB 143 folio 450 of the
63 records of St. Tammany Parish, Louisiana.
