17 An ordinance amending Chapter 11, Article III. Weeds
18 and Noxious Growths and Deposits*, Sections 11-50, 11-51, and
19 11-52 of the Code of Ordinances of the City of Slidell.

21 BE IT ORDAINED by the Slidell City Council, in legal
22 session convened, that Chapter 11, Article III. Weeds and noxious
23 Growths and Deposits* of the Code of Ordinances of the City of
24 Slidell is hereby amended as follows:

25
26 Sec. 11-50. Declared nuisance.

27
28 After the word "underbrush," add the following
29 language: "to a height of greater than twelve
30 (12) inches,".

31
32 Sec. 11-51. Duty to cut and remove.

33
34 After the word "underbrush" add the following
35 language: "exceeding a height of twelve (12)
36 inches,".

37
38 Sec. 11-52. Authority of city to cut.

39
40 Add the following paragraph to this section:

41
42 "Only one violation notice need be issued to the
43 property owner, owners, or authorized agent per
44 calendar year for similar violations of this Article
45 that occur on the same property."
