13 **ORDINANCE NO. 2201**  
14

15 An ordinance amending Section 520.02 B Permitted Signs:  
16 Free Standing, of Appendix A-Zoning of the Code of Ordinances of  
17 the City of Slidell, and establishing new sections 502.06.1 and  
18 520.03 H.  
19

20 WHEREAS, a recommendation was made to the Planning  
21 and Zoning Commission to allow for free standing signs; and  
22

23 WHEREAS, said commission forwarded this matter to the  
24 Slidell City Council without a recommendation.  
25

26 BE IT ORDAINED by the Slidell City Council that Section  
27 520.02 B of Appendix A-Zoning of the Code of Ordinances of the  
28 City of Slidell, is hereby amended as follows:  
29

30 Delete all language in Section 520.02 B of Appendix A-  
31 Zoning and replace with the following:  
32

33 520.02 Permitted Signs: Free Standing.  
34

35 B. A complex may only erect one (1) free-standing sign  
36 for the purpose of identifying the complex and/or the  
37 identification of each business located within the  
38 complex, except that a complex having four hundred and  
39 fifty feet (450) of frontage along a public  
40 right-of-way other than an alley, may erect one (1)  
41 additional free-standing sign. The size of a "complex  
42 sign" shall conform with the standards contained in  
43 Section 520.02 (c) (1) except that within a complex  
44 having six (6) or more separate tenant spaces and at  
45 least 10,000 square feet of total floor area, the size  
46 of the sign may exceed the standards contained in  
47 Section 520.02 (c) (1) by not more than one and one  
48 quarter (1.25) times. Also, within a complex, each  
49 free-standing building fronting upon a public  
50 right-of-way which has a minimum separation of fifty  
51 (50) feet from any other building in the same complex,  
52 is permitted one (1) non-complex sign provided that  
53 such free-standing sign is at least fifty (50) feet  
54 from any other sign in the complex.

9 BE IT FURTHER ORDAINED by the Slidell City Council that  
10 an additional Section 502.06.1 - Complex Sign be added to Appendix  
11 A-Zoning as follows:

14 Section 502.06.1 - Complex Sign.

15  
16 A sign displaying the name and/or address of the  
17 shopping complex and displaying business identification  
18 signs for two (2) or more businesses operating within  
19 the complex.

25 BE IT FURTHER ORDAINED by the Slidell City Council that  
26 an additional Section 520.03 H be added to Section 520.03  
27 Permitted Signs - Primary building sign of Appendix A-Zoning as  
28 follows:

30  
31

32 Section 520.03 H. If a business does not display  
33 building signs where such signage is permitted, such  
34 signage may be used on a side of the building where  
35 signage is not permitted provided that:

41 1. The total square footage of the sign(s) being  
42 installed does not exceed the maximum amount of  
43 signage permitted on the side of the building from  
44 where the signage is being swapped, or three (3)  
45 times the width in square feet of that side of the  
46 building where said signage is to be installed,  
47 whichever is least.  
48  
49 2. The wall, facia, canopy, or sloping roof where said  
50 signage is to be installed, must be immediately  
51 adjacent to and enclose the space of the business  
52 being advertised.  
53  
54 3. All signs shall conform with all other provisions  
55 of Section 520.03 of the Zoning Ordinance.
