18 **ORDINANCE NO. 2204**

20 An ordinance amending Chapter 17, Article III of the  
21 Code of Ordinances of the of Slidell, by adding thereto the terms  
22 of an Inter-Governmental Agreement between the Parish of St.  
23 Tammany, Louisiana; Sales Tax District No. 3 of the Parish of St.  
24 Tammany; the City of Slidell, Louisiana; and various other Cities  
25 within the Parish, in connection with the re-construction and  
26 maintenance of roads in St. Tammany Parish, Louisiana, and  
27 ratifying the execution of Resolution R88-45 adopted July 26,  
28 1988, by the Slidell City Council.  
29

30 WHEREAS, on July 26, 1988, the Slidell City Council  
31  
32 passed Resolution No. R88-45, accepting the terms of an  
33  
34 Inter-Governmental Agreement with the Parish of St. Tammany,  
35  
36 Louisiana and Sales Tax District No. 3 of the Parish of St.  
37  
38 Tammany, Louisiana; and

40 WHEREAS, on July 26, 1988, the City Council authorized  
41  
42 the Mayor to execute that Agreement.  
43

44 BE IT ORDAINED by the Slidell City Council:  
45

46 SECTION 1. That pursuant to the provisions of Article 6,  
47  
48 Sec. 20 and Article 7, Sec. 14(c) of the Louisiana Constitution,  
49  
50 LA. R.S. 33:1324, LA. R.S. 33:2721.6(G), LA R.S. 33:2711(C), and  
51  
52 other constitutional and statutory authority supplemental thereto,  
53  
54 the City Council of the City of Slidell, State of Louisiana,  
55  
56 hereby approves the terms and conditions of an Inter-Governmental  
57  
58 Agreement entered into by and between the Parish of St. Tammany ,  
59  
60 Louisiana; Sales Tax District No. 3 of the Parish of St. Tammany;  
61  
62 the City of Slidell, Louisiana; and various other Cities within  
63  
64 the Parish, in connection with the re-construction and maintenance  
65  
66 of roads in St. Tammany Parish, Louisiana, said Agreement being  
67  
68 attached hereto as Exhibit "A".  
69

70 SECTION 2. That this Council ratifies and confirms all  
71  
72 actions taken by the Mayor of the City of Slidell, State of  
73  
74 Louisiana in executing said agreement for, on behalf of, in the  
75  
76 name of and under the seal of the City of Slidell, State of  
77  
78 Louisiana.
