13 **ORDINANCE NO. 2208**

14
15 An ordinance amending Chapter 20 Water* of the Code of
16 Ordinances of the City of Slidell, to provide for a discount to
17 the handicapped.

18
19 WHEREAS, the City of Slidell charges a monthly fee for the
20 consumption of water; and

21
22 WHEREAS, the City of Slidell allows a discount for water
23 consumption for its senior citizens; and

24
25 WHEREAS, the Slidell City Council desires to allow this
26 same discount for its handicapped citizens.

27
28 NOW, THEREFORE, BE IT ORDAINED that the Slidell City
29 Council does hereby amend Chapter 20 Water* of the Code of
30 Ordinances of the City of Slidell as follows:

32 Sec. 20-7.1 Monthly rates for services; use of funds.

33
34 (c) Exemptions Concerning Water Bills.

35
36 Handicapped/disabled heads of household citizen or
37 citizens sixty-five (65) years or older of the
38 City of Slidell shall pay the following for water
39 consumption: First one-thousand (1,000) gallons, one
40 dollar (\$1.00); each one-thousand (1,000) gallons
41 thereafter, thirty cents (\$.30). The term
42 "handicapped/disabled person" shall include any person
43 who has impairments which, regardless of cause of
44 manifestation, for all practical purposes, confines the
45 person to a wheel chair, or any person who has
46 impairments which cause the person to walk with
47 difficulty or insecurity and includes, but is not
48 limited to, those persons using braces or crutches,
49 amputees, arthritics, spastics, and those with pulmonary
50 or cardiac illnesses who may be semi-ambulatory. Each
51 application shall be accompanied by a currently dated
52 physician's statement certifying that the applicant is a
53 handicapped/ disabled person. The provisions of Chapter
54 2 Administration Article VIII Sections 2-121 through
55 2-125 shall be applicable to this provision.
