21 of the Code of Ordinances of the City of Slidell is hereby amended  
22 as follows:

27 Sec. 3-2 Definitions. (1) Alcoholic beverage delete  
28 "one-half of one (0.5)" and replace with "six percent".  
29 After the last word in the paragraph "volume", delete  
30 the period "(.)" and replace with ", including alcohol".

34 "(5) Dealer:" first sentence after "Any person who"  
35 add " as a business,".

39 "(10) Liquor wholesaler" Third sentence after the  
40 language "state or who", add the following "sells  
41 alcoholic beverages for delivery beyond the borders of  
42 the State in the amounts to be fixed by the  
43 commissioners,".

48 Add "(19) Restaurant: Any establishment defined as  
49 follows:
