18 Bingo, and Keno Licensing, to provide for additional days of
19 operation.

21 BE IT ORDAINED by the Slidell City Council, in legal
22 session convened, that Ordinance No. 2117, an ordinance
23 establishing Raffles, Bingo, etc., policies for the City of
24 Slidell is hereby amended as follows:

25
26 Page 1, Line 31: Delete the word "city" and replace
27 with "eighth and ninth wards of St. Tammany Parish".

28
29 Add the following: Page 1, Line 35, after the
30 word "their" add "association".

31
32 Page 1, Line 35: Delete "City of Slidell" and replace
33 with "eighth and ninth wards of St. Tammany Parish".

34
35 Page 1, Line 68: Add the following "The City of
36 Slidell shall have the authority to require copies of any
37 State of Louisiana required bingo reports from any
38 organization conducting bingo within the City of Slidell."

39
40 Page 2, Line 16: Delete the words "eighteen (18)"
41 and add the words "six (6)", and delete the word "month" and
42 add the word "week".

43
44 Page 2, Line 20: Delete the words "eighteen (18)" and
45 add the words "six (6)".

46
47 Page 2, Line 22: Delete the word "month" and add the
48 word "week".

49
50 Page 2, Line 38: Delete the words "eighteen (18)" and
51 add the words "six (6)", and delete the word "month" and add the
52 word "week".

53
54 Page 2, Line 44: After the period ".", add "Only one
55 four (4) hour session shall be permitted each day. Commercial
56 bingo establishments are hereby required to conduct their games
57 between the hours of 6:00 p.m. and midnight."
