48 Subparagraph (9)(d), after the last sentence delete

50 the "." and add the following:

52 ", or shall be a graduate from any state licensed

54 trade school with three (3) years of experience in

56 that class of occupation or business governed by

58 the license for which applicant is being made."
