14 **ORDINANCE NO. 2265**

16 An ordinance annexing and zoning approximately 0.41  
17 acres of land from Parish to A-6 Single Family Urban Zoning  
18 District, located south of Fremaux Extension and west of Joan  
19 Avenue, as petitioned by Lakewood Congregation of Jehovah's  
20 Witnesses.  
21

22 WHEREAS, the Slidell City Council received a petition  
23 from Lakewood Congregation of Jehovah's Witnesses to annex and  
24 zone approximately 0.41 acres of land from Parish to A-6 Single  
25 Family Urban Zoning District; and

28 WHEREAS, said property is located south of Fremaux  
29 extension and west of Joan Avenue; and  
30  
31

32 WHEREAS, the Slidell Planning and Zoning Commission has  
33 issued a favorable response for such annexation and zoning.

36 NOW THEREFORE BE IT ORDAINED by the Slidell City Council  
37 that the following described parcel of land more fully identified  
38 on Exhibit "A" attached hereto and made a part hereof, be annexed  
39 and zoned from Parish to A-6 Single Family Urban Zoning District  
40 into Councilmanic District E:

43 From the Northeast corner of the Northeast quarter  
44 of Southwest quarter of Section 11, Township 9 South,  
45 Range 14 East of said parish, go West 279.0 feet to  
46 the point of beginning. Thence continue West 105.0  
47 feet to a point, thence go South 171.0 feet to a  
48 point; thence go East 105.0 feet to a point; thence  
49 go North 171.0 feet to the Point of Beginning.
