**ORDINANCE NO. 2270**

An ordinance establishing a Farmer's Market within the  
City Limits of the City of Slidell.

WHEREAS, the residents of the City of Slidell and St.  
Tammany Parish harvest an abundance of products including fresh  
vegetables, fruits, nuts, and seafood; and

WHEREAS, said residents have expertise in various  
crafts; and

WHEREAS, a Farmer's Market would provide a retail outlet  
for such products; and

WHEREAS, citizens and visitors of the City of Slidell  
would benefit from having these products available for purchase and  
consumption.

NOW THEREFORE BE IT ORDAINED by the Slidell City Council  
in legal session convened, that a Farmer's Market whereat fresh  
vegetables, fruits, nuts, seafood, and home crafts could be sold  
is hereby authorized within the City Limits of the City of Slidell  
in accordance with the provisions herein.

BE IT FURTHER ORDAINED that the Permit and Planning  
Departments are authorized to investigate and recommend to the  
Council for approval such rules, regulations, procedures,  
licensing requirements, permit requirements, fees, and penalties  
for violations thereof, pertinent to the successful operation of  
said market.

BE IT FURTHER ORDAINED that said rules, regulations,  
procedures, licensing requirements, permit requirements, fees,  
and penalties for violations thereof shall be printed in booklet  
form and made available to the public for a reasonable fee.

BE IT FURTHER ORDAINED that said Farmer's Market be  
located in an area which has a minimum zoning requirement of C-3.






