18 An ordinance deleting the provision of Sec. 9-50 Minors
19 under the age of seventeen (17) not permitted in pool or billiard
20 halls of Chapter 9 Criminal Code of the Code of Ordinances of the
21 City of Slidell.

23 WHEREAS, Louisiana State law has provisions governing
24 minors access to pool and billiard halls where alcoholic beverages
25 are sold; and

28 WHEREAS, the City of Slidell has family amusement
29 centers in which the games of pool and billiards are played and no
30 alcoholic beverages are served; and

33 WHEREAS, many bowling establishments and other similar
34 businesses have pool and/or billiard tables, but said games are
35 not the primary purpose of the business.

38 NOW THEREFORE BE IT ORDAINED by the Slidell City Council
39 that Sec. 9-50 Minors under the age of seventeen (17) not permitted
40 in pool or billiard halls. of Chapter 9 Criminal Code of the Code
41 of Ordinances of the City of Slidell is hereby deleted and
42 replaced with the following:

45 "Sec. 9-50. Minors under the age of eighteen (18) not
46 permitted in certain establishments where
47 pool or billiards is played.

50 The following sections of the State Alcoholic
51 Beverage Control Law (as may be hereafter amended) are
52 adopted by reference and are made part of this section
53 insofar as they apply to municipalities, each reference
54 being the Louisiana Revised Statutes:
