15 **ORDINANCE NO. 2301**

18 An ordinance amending Chapter 18 Taxicabs* of the Code of
19 Ordinances of the City of Slidell requiring taxicab services to be
20 licensed by the City.

21
22 BE IT ORDAINED by the Slidell City Council that Chapter
23 18 Taxicabs* of the Code of Ordinances of the City of Slidell is
24 hereby amended by adding the following sections:
25

27 "Sec. 18-7. Pickup service, unlawful unless licensed in the
28 City.
29

30
31 It shall be unlawful for any person operating any motor
32 vehicle used in a taxicab service, who is not licensed in
33 the city and does not maintain a station within the city, to
34 provide pickup service for citizens within the city. Round
35 trip pickups will be allowed when the charge for services
36 are paid in advance and the taxicab service waits for the
37 customer at a designated location within the city.

40 Sec. 18-8. Enforcement.
41

42 The provisions of this chapter shall be subject to
43 enforcement by the Slidell Police Department."

46 BE IT FURTHER ORDAINED as follows:
47

49 1. Sec. 18-2. Occupational license required. is hereby
50 deleted and replaced with the following:
51

52 "Sec. 18-2 Taxicab license required.
53

54 It shall be unlawful to operate a taxicab
55 or taxicab business unless a taxicab license
56 therefore has been obtained. The taxicab
57 license shall be prominently displayed in the
58 vehicle at all times. The fee for the license
59 shall be ten dollars (\$10.00) for each taxicab
60 per calendar year."


