18 An ordinance establishing a new chapter in the Code of
19 Ordinances of the City of Slidell to be known as Chapter 12 3/4
20 Police Department.

22 WHEREAS, the City of Slidell has received a study
23 concerning the management and operation of the Slidell Police
24 Department from the International Association of Chiefs of Police
25 (I.A.C.P.); and

29 WHEREAS, said report contains many recommendations for
30 policy and/or procedural changes within said police department.

33 NOW THEREFORE BE IT ORDAINED by the Slidell City Council
34 that a new chapter entitled Police Department is hereby
35 established within the Code of Ordinances of the City of Slidell
36 as follows:

40 Police Department

42 Sec. 12 3/4-1. Legislative intent.
43

44 It is the intent of the governing authority of the
45 City of Slidell to enact policies and procedures for the
46 management and operation of the Slidell Police Department.


48 Sec. 12 3/4-2. Prohibitions.
49

50 No member of the Slidell Police Department shall assist
51 the City Marshal's Office in the pursuit of its duties
52 without the prior permission of the Chief of Police unless a
53 Marshal's Office employee or agent encounters a situation
54 endangering property or the safety of a person. A detailed
55 report of every instance in which a Slidell police officer
56 assists an employee or agent of the City Marshal's Office
57 shall be forwarded to the Chief of Police and Mayor within
58 forty-eight (48) hours of the incident. The report shall
59 include the name of the person making the request, the reason
60 why the request was made and what action was taken."


