17 An ordinance dedicating various City owned parcels of
18 property as utility and access right-of-ways.
19

20 WHEREAS, residents on streets adjacent to John Slidell
21 Park have requested that these streets not be extended into the
22 Park; and

26 WHEREAS, the City plans to revoke the last ten feet
27 (10') of the dedication of Northam Drive and Everest Drive
28 adjacent to John Slidell Park; and

32 WHEREAS, the City must maintain a right-of-way for
33 utilities and pedestrian access in the street right-of-ways which
34 are to be revoked.

38 NOW THEREFORE BE IT ORDAINED by the Slidell City Council
39 that the following described parcels of land, delineated on the
40 sketches attached hereto and made a part hereof, are hereby
41
42 dedicated to the public as utility right-of-ways:

46 **PARCEL 1:** From the northeast corner of Lot 615, Country Club
47 Estates Subdivision, which is the Point of Beginning go east
48 60 feet to a point which is the northwest corner of Lot 614,
49 thence go south 10 feet along the west lot line of Lot 614
50 to a point; thence go west 60 feet to a point, which is on the
51 east lot line of Lot 615, thence go north 10 feet along the
52 east lot line of Lot 615 back to the Point of Beginning.
53

54 **PARCEL 2:** From the southeast corner of Lot 590 of Slidell
55 Country Club Estates Subdivision, which is the Point of
56 Beginning, go south 30 feet along the easterly right-of-
57 way of Northam Drive to the centerline of Northam Drive,
58 thence go west 20 feet along the centerline of Northam Drive
59 to a point, thence go south a distance of 30 feet to the
60 northeast corner of Lot 489 of Slidell Country Club Estates
61 Subdivision, thence go west 5 feet along the northerly lot
62 line of Lot 489 to a point, thence go north 00 degrees, 06
63 minutes, 00 seconds west 60 feet to a point on the southerly
64 lot line of Lot 590, thence go east 25 feet along the
65 southerly lot line of Lot 590 to the Point of Beginning.


67 BE IT FURTHER ORDAINED that the following described

13 **PARCEL 3:** From the southeast corner of Lot 590 of Slidell
14 Country Club Estates Subdivision go south 20 feet along the
15 easterly right-of-way of Northam Drive to the Point of
16 Beginning, thence go south 10 feet along the easterly right-
17 of-way line of Northam Drive to the centerline of Northam
18 Drive, thence go west 25 feet along the centerline of Northam
19 Drive to a point, thence go North 00 degrees, 06 minutes, 00
20 seconds west 10 feet to a point, thence go east 25 feet to
21 the Point of Beginning.



23 **PARCEL 4:** From the northeast corner of Lot 615 of Country
24 Club Estates go east 30 feet to the Point of Beginning which
25 is the centerline of Everest Drive. From the Point of
26 Beginning go south 10 feet along the centerline of Everest
27 Drive to a point, thence go east 10 feet to a point, thence
28 go north 10 feet to a point on the northerly right-of-way of
29 Everest Drive, thence go west 10 feet back to the Point of
30 Beginning. Containing 100 square feet in area.


