20 9 Criminal Code, Section 9-81. Regulating parades, of the Code of
21 Ordinances of the City of Slidell.

23 NOW THEREFORE BE IT ORDAINED by the Slidell City Council
24 that Chapter 3 Alcoholic Beverage Control, Section 3-20.

25 Certificates of qualification. is hereby amended as follows:

26
27 Paragraph (1), delete the language "City of Slidell Police
28 Department" and replace with "City of Slidell Finance
29 Department".

30
31 Paragraph (2), delete the language "and fingerprinting" from
32 the title.

33
34 Paragraph (2), delete the language "and fingerprinted by the
35 Slidell Police Department" and replace with "by the
36 City of Slidell".

37
38 Paragraph (2) delete "fifteen dollars (\$15.00)" and replace
39 with "thirty dollars (\$30.00)".

40
41 Paragraph (2), add the following language at the end of this
42 paragraph: "License shall be valid for two (2) years."

43
44 Paragraph (3), after the words "Each Applicant" in the
45 first sentence, add ", whether original or renewal,".

46
47 Paragraph (3), add the following subparagraph

48
49 "(h) Original applicants must have completed the St.
50 Tammany Sheriff's Department course entitled
51 'Responsible Alcohol Service'. Renewal applicants
52 must have completed the 'Responsible Alcohol Service
53 Refresher Course'."

55 Paragraph (5)(a), delete "chief of police" and replace with
56 "Director of Finance".

13 Paragraph (5)(b), delete "chief of police" and replace with
14 "Director of Finance, with the concurrence of the Mayor
15 or his designee".

19 Paragraph (7), delete two (2) occurrences of "chief of
20 police" and replace same with "Director of Finance."

23 BE IT FURTHER ORDAINED that Chapter 9 Criminal Code,
24 Section 9-81. Regulating parades. is hereby amended as follows:

29 "(1) Mayor is the Mayor of this Municipality."

32 accordingly.

35 Paragraph (B), delete "chief of police" and replace with
36 "Mayor, or his designee".

39 Paragraph (C), delete "chief of police" and replace with
40 "Mayor, or his designee,".

43 Paragraph (C)(1), delete "chief of police" and replace with
44 "Mayor, or his designee,".
45

47 Paragraph (C)(2)(1), delete "chief of police" and replace
48 with "Mayor, or his designee,".
49

51 Paragraph (C)(2)(m), delete "chief of police" and replace
52 with "Mayor, or his designee,".

55 Paragraph (C)(3), delete "chief of police" and replace with
56 "Mayor, or his designee,".

59 Paragraph (D), delete "chief of police" and replace with
60 "Mayor, or his designee,".

63 Paragraph (D), add the following subparagraph:

65 "(9) The Chief of Police concurs with the date, time
66 schedule and parade route and is able to assign
67 sufficient officers to safely manage the parade."

28 given notice in writing to the applicant setting forth
29 the reasons for such denial or revocation."


