24 that Chapter 2 Administration, Article XI. Organizational Plan for  
25 City Government, of the Code of Ordinances of the City of Slidell  
26 is hereby amended as follows:

30 Replace the current organizational plan with the attached  
31 organizational plan entitled "Exhibit A".

34 Section 2-163. Chief of police; police department., second  
35 paragraph, delete ", and has general charge over the  
36 division of animal control and the division of emergency  
37 preparedness." and replace with a period ".".

40 Section 2-166. Department of administration., first sentence,  
41 delete "the city attorney, the city prosecutor".  
42

43  
44 Add new sections as follows:  
45

46  
47 "Sec. 2-176. Office of Airport Manager.  
48

49  
50 This office reports directly to the Department of  
51 Administration and is responsible for the management and  
52 operations of the Slidell Airport. This office is also  
53 the marketing center for the Slidell Airport and  
54 performs other related duties.



57 Sec. 2-177. Office of Animal Control.  
58

59  
60 This office reports directly to the Department of  
61 Administration and is responsible for keeping stray,  
62 lost, surrendered and vicious animals from becoming a  
63 hazard to the health and safety of the community. The  
64 office also provides for humane treatment and/or humane  
65 disposal of all animals under its care and jurisdiction."


