21 WHEREAS, the Slidell City Council has received a
22 request from Ms. Dolores Williams, representing Ms. Maris Pravata
23 Leitz, Ms. Linda Pravata Bolian, Ms. Barbara Pravata Penton, and
24 Ms. Renell Pravata Dore, to rezone 2.21 acres of land from A-
25 6 Single Family Urban to A-4 Transitional Zoning District; and


43 ALL THAT CERTAIN LOT OR PARCEL OF LAND, lying and being
44 situated in Section 4, Township 9 South, Range 14 East, 9th
45 Ward, St. Tammany Parish, Louisiana, more fully described as
46 follows: From the NE corner of Section 38, T9S, R14E, go
47 South 27 degrees, 15 minutes West 235.0 feet; thence South 13
48 degrees, 00 Minutes East 775.5 feet; thence go North 73
49 degrees, 00 minutes East 1389.0 feet; thence go North 13
50 degrees, 36 minutes West 30 feet to the Point of Beginning;
51 thence go North 11 degrees, 30 minutes West 185 feet; thence
52 go South 88 degrees, 07 minutes West 365.90 feet; thence go
53 South (along the easterly margin of Maris Stella Avenue).
54 279.83 feet; thence go North 73 degrees East 153.4 feet to
55 the Point of Beginning.


