26 WHEREAS, Amendment D incorrectly stated the remaining

45 (funding of \$9,000 Pearl Street
46 and \$21,000 Rue Verand roadway

49 5. Amendment D - reduced to 119,000 (incorrect
50 (establishment of \$174,000 balance)
51 Bond Fund Reserve)

53 6. Correct balance should be 55,000
54 (\$229,000 less \$174,000
55 which equals \$55,000)



14 Ordinance No. 2367 is hereby amended as follows:


