18 An ordinance amending Section 2.2215 of Appendix
19 A-Zoning of the Code of Ordinances of the City of Slidell.

20
21 WHEREAS, Ordinance No. 2382 was adopted by the Slidell
22 City Council on May 14, 1991; and

23
24 WHEREAS, said ordinance established new provisions for
25 industrial zoning; and

26
27 WHEREAS, Section (E) (2) of said ordinance had
28 provisions wherein the Zoning Commission would make final
29 determination of all conditional use permits.

30
31 NOW THEREFORE BE IT ORDAINED by the Slidell City Council
32 that Section 2.2215, paragraph (E) (2) of Appendix A-Zoning of the
33 Code of Ordinances of the City of Slidell is hereby amended as
34 follows:

35
36 Delete all language in paragraph (E) (2) and replace with the
37 following:

38
39 "(2) Determination - The Zoning Commission shall within
40 forty-five (45) days after the close of the public
41 hearing render its decision. The Zoning Commission
42 may recommend approval or denial of the special use
43 permit or approval with the addition of special
44 conditions or restrictions deemed necessary to
45 secure the standards found in Section 2.2215.
46 Upon rendering its decision the secretary of the
47 Commission shall within seven (7) working days
48 report the Commission's decision and findings to
49 the Clerk of the Council. Upon receiving the
50 recommendations of the Zoning Commission the City
51 Council may approve or deny the special use permit
52 request in accordance with the recommendation of
