15 **ORDINANCE NO. 2408**

18 An ordinance amending Chapter 10 Fire Protection and  
19 Prevention of the Code of Ordinances of the City of Slidell to  
20 authorize Fire Protection District No. 1 to seek reimbursement for  
21 materials and manpower used at the scene of a Hazardous Materials  
22 Incident.  
23

24 WHEREAS, the State of Louisiana has recently enacted  
25 legislation to allow local fire districts reimbursement for costs  
26 associated with cleaning up hazardous material incidents.  
27

28 NOW THEREFORE BE IT ORDAINED by the Slidell City Council  
29 that Article II. Fire Prevention of Chapter 10 Fire Protection and  
30 Prevention of the Code of Ordinances of the City of Slidell is  
31 hereby amended as follows:  
32

33 Delete "Sec. 10-13. Amendments to code." and replace with the  
34 following:  
35

36 "Sec. 10-13. Hazardous Materials Incident Reimbursement.  
37

38 (a) Fire Protection District No. 1 shall have the authority  
39 to charge any person causing or contributing to a  
40 discharge of a hazardous or non-hazardous material or  
41 substance the extraordinary expenses of undertaking any  
42 remedial actions necessary to contain, abate, clean up,  
43 restore, or remove the discharge.  
44

45 (b) The Board of Commissioners of Fire Protection District  
46 No. 1 who assess charges for remedial costs for action  
47 taken in cleaning up any discharge of hazardous or non  
48 hazardous material or substance shall also have the  
49 authority to use any reasonable means to collect and  
50 enforce the collection of such costs.  
51

52 (c) In any such action, the Board of commissioners of Fire  
53 Protection District No. 1 shall be entitled to recover  
54 the amount of said costs, together with costs of court  
55 and reasonable attorney fees."
