18 An ordinance annexing and zoning approximately one (1)
19 acre of land located at Tyler Street and I-10 Service Road, from
20 Parish Highway Commercial to C-4 Highway Commercial, as petitioned
21 by CEBCO Investments, Inc. (Econo Lodge Motel).

23 WHEREAS, the Slidell City Council has received a
24 petition from CEBCO Investments, Inc. (Econo Lodge Motel) to annex
25 and zone approximately one (1) acre of land from Parish Highway
26 Commercial to C-4 Highway Commercial Zoning District; and

29 WHEREAS, said property is bounded by Manzella Drive,
30 Tyler Street and Yaupon Drive; and

33 WHEREAS, the Slidell Planning and Zoning Commission has
34 issued a favorable recommendation for said annexation and zoning.

37 NOW THEREFORE BE IT ORDAINED by the Slidell City Council
38 that the following described parcel of land be annexed into the
39 corporate limits of the City of Slidell into Councilmanic District
40 E and zoned C-4 Highway Commercial Zoning District:

43 From the intersection of the Southerly Right-of-Way line
44 of Gause Road and the Westerly Right-of-Way line of Yaupon
45 Drive; thence along said Westerly Right-of-Way line of
46 Yaupon Drive in a Southerly Direction 105.0 feet to the
47 Point of Beginning. Thence along said Westerly Right-of-way
48 line of Yaupon Drive in a Southerly direction 145.2 feet to
49 a point; thence in a Westerly direction 300.0 feet to the
50 Easterly Right-of-Way line of Tyler Drive; thence along said
51 Easterly Right-of-Way line of Tyler Drive in a Northerly
52 direction 87.52 feet; thence along said Easterly Right-of-way
53 line of Tyler Drive in a Northeasterly direction 57.76 feet
54 to a point; thence in a Easterly direction 297.91 feet to the
55 Point of Beginning.
