13 An ordinance amending Section 4-05. Police Department of
14 the Home Rule Charter of the City of Slidell to provide for an
15 appointed Chief of Police.
16

17 BE IT ORDAINED by the Slidell City Council that it does
18 hereby call an election at which shall be submitted to the electors
19 of the City of Slidell, for their approval or rejection, certain
20 proposals to amend Section 4-05. Police Department of the Home Rule
21 Charter for the City of Slidell relative to the appointment of the
22 Chief of Police and to otherwise provide with respect thereto by
23 repealing the present section and replacing it with the following:

26 **Section 4-05. Police Department.**
27

29 A. "The head of the police department shall be the
30 police chief who shall be appointed by the mayor
31 and confirmed by the majority vote of the
32 authorized membership of the council. The police
33 chief shall serve at the pleasure of the mayor,
34 other provisions of the charter notwithstanding.
35 The chief, at the time of appointment, shall have
36 proven law enforcement experience, shall have
37 served in command or supervisory positions, and
38 shall have successfully completed a state or
39 national law enforcement training program.

42 B. The police chief shall direct and be responsible
43 for the preservation of public peace and order;
44 prevention of crime; apprehension of criminals;
45 assistance to the courts and other law enforcement
46 officials, and the enforcement of the laws of the
47 state and ordinances of the council of the City of
48 Slidell."
