10 ORDINANCE NO. 2459

12 An ordinance amending Chapter 12 1/4 Parks and Recreation
13 of the Code of Ordinances of the City of Slidell to provide rules
14 and regulations for the use of John Slidell Park Gymnasium and
15 Recreation Center.
16

17 BE IT ORDAINED by the Slidell City Council that it does
18 hereby amend Chapter 12 1/4 Parks and Recreation by adding a new
19 section as follows:

22 "Sec.12 1/4-9. John Slidell Park Gymnasium and Recreation
23 Center Rules and Regulations.
24

26 The rules and regulations for the John Slidell Park
27 Gymnasium and Recreation Center shall be as follows:

31 1) All persons desiring to utilize the John Slidell Park
32 Gymnasium must first register with the Department of
33 Parks and Recreation and obtain a registration card.
34 Said registration card will be valid for two (2) years.
35 The cost for a registration card shall be two dollars
36 (\$2.00) for persons fifteen (15) years of age and older.
37 Persons under the age of fifteen (15) will be able to
38 obtain a fee free card.
39 Each player and/or league must sign in with the
40 Recreation Office every time they utilize the John
41 Slidell Park Gymnasium.
42
43 2) There will be no smoking, chewing tobacco, drugs,
44 alcoholic beverages, glass containers and chewing gum
45 permitted in the John Slidell Park Gymnasium.
46
47 3) Persons utilizing the John Slidell Park Gymnasium will be
48 held responsible for any willful damage to City property.
49
50 4) All John Slidell Park Gymnasium event participants will
51 be required to wear shoes with non-marking soles whenever
52 utilizing the gymnasium for any function.
53
54 5) The John Slidell Park Gymnasium will be utilized
55 primarily for athletic or athletic related activities.
56 First priority will be give to youth athletic leagues.

- 7 6) On an availability basis, and with the approval of the
8 Director of Parks and Recreation and the Chief of Staff,
9 the John Slidell Park Gymnasium may be rented out for
10 other functions.
11
12 7) The rules and regulations for rental of the John Slidell
13 Park Gymnasium shall be the same as those outlined in
14 Ordinance No. 2069 as amended and where applicable, for
15 the rental of the Slidell Auditorium.
16
17 8) Any group renting the John Slidell Park Gymnasium for
18 non-athletic activities will be responsible for supplying
19 and setting up, under the supervision of the Recreation
20 Department, their own tables and chairs.
21
22 9) Hours of operation of the John Slidell Park Gymnasium
23 will be set by the Director of Parks and Recreation and
24 prominently posted near the entrance to the gymnasium.
25
26 10) During regular scheduled hours, the meeting room will be
27 available for use by non-profit organizations at no
28 charge."


