9 **ORDINANCE NO. 2480**

11 An ordinance rezoning approximately 1.2 acres of land located at the  
12 northwest corner of U. S. Highway 190 and St. Tammany Avenue, from A-7 Multi-  
13 Family Urban to C-4 Highway Commercial Zoning District, as petitioned by Mr. Alvin  
14 M. Alexander and Mrs. Pamela A. Herman.  
15

16 WHEREAS, the Slidell City Council has received a petition from Mr. Alvin  
17 M. Alexander and Mrs. Pamela A. Herman for the rezoning of approximately 1.2 acres  
18 of land from A-7 to C-4; and  
19  
20 of land from A-7 to C-4; and

22 WHEREAS, said property is located on the northwest corner of U. S.  
23 Highway 190 and the undeveloped portion of St. Tammany Avenue; and  
24

25 WHEREAS, the Slidell Planning and Zoning Commission has issued a  
26 favorable recommendation for said rezoning.

28 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the  
29 following described parcel of land be rezoned from A-7 Multi-Family Urban to C-4  
30 Highway Commercial Zoning District:

36 A CERTAIN LOT OF LAND, together with all building and improvements  
37 thereon, situated in Lot No. 5 of Section 4, Township 9 South, Range 14 East, St.  
38 Tammany Parish, Louisiana, more fully described as follows:

40 From the northeast corner of said Lot No. 5 go south 504.6 feet to the north line  
41 of the old Slidell-Covington Highway; thence go north 73 degrees east 166.9 feet  
42 along the present fence line on the north edge of said highway; thence go north  
43 12 degrees 20 minutes east 466.8 feet; thence go east 58.7 feet to the beginning.


