9 An ordinance revoking and closing approximately three hundred thirty-one
10 feet (331') of Medical Center Drive.

12 WHEREAS, the Slidell City Council has received a request from National
13 Medical Enterprises and Northshore Regional Medical Center for the revocation of that
14 portion of Medical Center Drive that abuts Walmart's property.
15

16 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it
17 does hereby revoke that portion of Medical Center Drive that is shown in Exhibit A
18 attached hereto, and more fully described as follows:

20 All that certain parcel of land situated in Small's Subdivision, City of Slidell, Section
21 1, Township 9 South, Range 14 East, St. Tammany Parish, Louisiana, more fully
22 described as follows:


24 From the section corner common to Sections 1 and 12, Township 9 South, Range
25 14 East, and Sections 6 and 7, Township 9 South, Range 15 East of said Parish,
26 go North 00 degrees, 01 minutes, 00 seconds West 50.00 feet to a point; Thence
27 go North 50.00 feet to a point; Thence, go North 89 degrees, 55 minutes, 00
28 seconds West 2,657.20 feet to a point on the northerly right-of-way of Gause Road
29 Extension; Thence go North 00 degree, 01 minutes, 00 seconds West 885.90 feet
30 to a point; Thence go North 87 degrees, 52 minutes, 12 seconds East 1.00 feet
31 to the point of beginning; Thence go North 00 degrees 01 minutes, 00 seconds
32 East 64.04 feet to a point; Thence go South 89 degrees, 55 minutes, 00 seconds
33 East 331.00 feet to a point; Thence go South 00 degrees, 01 minutes, 00
34 seconds, East 75.86 feet to a point; Thence go North 87 degrees, 52 minutes, 12
35 seconds West 331.23 feet to the point of beginning;


