10 An ordinance annexing and zoning ten (10) acres of land located off Terrace
11 Avenue, from Parish to A-6 Single Family Urban as petitioned by Slidell Bantam Baseball
12 Association.

14 WHEREAS, the Slidell City council has received a petition from the Slidell
15 Bantam Baseball Association to annex and zone the remaining ten (10) acres of land
16 from Parish to A-6 Single Family Urban; and

18 WHEREAS, said property is located off Terrace Avenue and owned by the
19 Slidell Bantam Baseball Association; and

21 WHEREAS, the Slidell Planning and Zoning Commission has issued a
22 favorable recommendation for said annexation and rezoning.

24 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the
25 following described property be annexed into the corporate limits of the City of Slidell into
26 Councilmanic District A and zoned A-6 Single Family Urban:

28 Ten (10) acres of land, lying and being situated in the southwest corner of the
29 northwest quarter of the southwest quarter of Section 14, Township 9 South,
30 Range 14 East, Ninth Ward, St. Tammany Parish, Louisiana, more fully described
31 as follows:



33 Commencing at the southwest corner of the said northeast quarter of the
34 southwest quarter of said section which is the point of beginning, go east 660 feet;
35 thence north 660 feet; thence west 660 feet; thence go south 660 feet back to the
36 point of beginning.




