9 **ORDINANCE NO. 2496**

11 An ordinance for the City of Slidell which shall set forth and designate the
12 adjusted millage rates as required by Paragraph B of Section 23, Article VII of the
13 Constitution of Louisiana, for the purpose of maintenance and operation of the Police
14 Department, Garbage Collection, Sewer System, Public Works, General Government, as
15 well as providing for the payment of interest and principal on outstanding general
16 obligation bonds, in said City for the year 1994.
17

18 SECTION 1. BE IT ORDAINED by the Slidell City Council of the City of
19 Slidell, Louisiana, in legal session convened, that there is hereby levied an aggregate tax
20 of thirty-five and eleven one hundredths (35.11) mills on the dollar upon all property
21 taxable, under the laws of the State of Louisiana, situated in said City, according to the
22 assessment roll of said City in the calendar year 1993.

28 SECTION 2. BE IT FURTHER ORDAINED that said aggregate tax is
29 composed of the following individual authorized tax levys: a tax of 6.11 mills for the
30 purpose of raising and providing sufficient revenues to pay and defray the expenses of
31 the municipal government and for the general municipal and local purposes in the City
32 of Slidell, Louisiana, for the year 1993, as shown by the budget for the year 1993,
33 adopted by the City Council of said City. So authorized by Louisiana Constitution Article
34 VI, Section 27 at 6.11 mills.

42 A tax of 3 mills for the purpose of maintenance and operation of the Municipal
43 Police Department in the City of Slidell, Louisiana, for the year 1993. So authorized by
44 the special taxpayer election held in the City of Slidell, Louisiana, November 16, 1985.

48 A tax of 2.50 mills for the purpose of maintenance and operation of the Municipal
49 Police Department in the City of Slidell, Louisiana, for the year 1993. So authorized by
50 the special taxpayer election held in the City of Slidell, Louisiana, April 4, 1981.

54 A tax of 5 mills for the purpose of garbage disposal and maintenance in the City
55 of Slidell, Louisiana, for the year 1993. So authorized by the special taxpayer election
56 held in the City of Slidell, Louisiana, September 27, 1986.

11 A tax of .64 mills for the purpose of providing an amount sufficient to pay interest
12 and maturing bonds for the 1974 Street Improvements Bonds of the City of Slidell,
13 Louisiana, for the year 1993, as authorized by a special taxpayers election held
14 December 15, 1973, and by a Resolution of the Mayor and Councilmen of the City of
15 Slidell, Louisiana, passed on the 18th day of December, 1973, and January 22, 1974.

18 A tax of 2.5 mills for the purpose of maintaining, operating, and improving public
19 works within the City of Slidell, Louisiana, for the year 1993. So authorized by the special

22 A tax of .70 mills for the purpose of providing an amount sufficient to pay interest
23 and maturing bonds for the 1974 Road Improvement Bonds of the City of Slidell,
24 Louisiana, for the year 1993, as authorized by a special taxpayers election held
25 December 15, 1973, and by a Resolution of the Mayor and Councilman of the City of
26 Slidell, Louisiana, passed on the 18th day of December, 1973, and January 22, 1974.

28 A tax of .23 mills for the purpose of providing an amount sufficient to pay interest
29 and maturing bonds for the 1974 Drainage Improvement Bonds Series C of the City of
30 Slidell, Louisiana, for the year 1993, as authorized by a special taxpayers election held
31 December 15, 1973, and by a Resolution of the Mayor and the Councilmen of the City
32 of Slidell, Louisiana, passed on the 18th day of December, 1973 and January 22, 1974.

35 A tax of .71 mills for the purpose of providing an amount sufficient to pay interest
36 and maturing bonds for the 1976 Drainage Improvement Bonds Series A of the City of
37 Slidell, Louisiana, for the year 1993, as duly authorized by a special taxpayers election
38 held April 13, 1976, and by a Resolution of the Mayor and the Councilmen of the City of
39 Slidell, Louisiana, passed on the 13th day of April, 1976, and the 25th day of May, 1976.



9 Slidell, Louisiana, passed on the 13th day of April 1976, and the 16th day of November,
10 1976.

12 A tax of 1.96 mills for the purpose of providing an amount sufficient to pay interest
13 and maturing bonds for the 1977 Sewerage Improvement Bonds of the City of Slidell,
14 Louisiana, for the year 1993, as duly authorized by a special taxpayers election held April
15 13, 1976, and by a Resolution of the Mayor and the Councilmen of the City of Slidell,
16 Louisiana, passed on the 13th day of April 1976, and the 16th day of November, 1976.


18 A tax of 5.42 mills for the purpose of providing an amount sufficient to pay interest
19 and maturing bonds for the 1989 Water Bonds Series A, and 1989 Sewer Bonds Series
20 B, and the 1989 Refunding Bonds Series C of the City of Slidell, Louisiana, for the year
21 1993, as authorized by a special taxpayers election held November 8, 1988, and by a
22 Resolution of the Mayor and the Councilmen of the City of Slidell, Louisiana, passed on
23 the 24th day of January 1989.
