**ORDINANCE NO. 2504**

An ordinance amending Appendix A-Zoning of the Code of Ordinances of the City of Slidell relative to semi-trailers in commercially zoned districts.

WHEREAS, the Slidell Planning and Zoning Commission has issued a favorable recommendation for said amendments.

NOW THEREFORE BE IT ORDAINED by the Slidell City Council that Appendix A-Zoning of the Code of Ordinances be amended as follows:

In Part 2. Schedule of District Regulations Adopted, add a new subsection to Section 2.16. C-2 Neighborhood Commercial as follows:

"2.1601A Conditional Uses: Trailers as defined by Section 9.31e and in accordance with the procedures and standards of Section 2.2215."

In Part 2. Schedule of District Regulations Adopted, after the word "purposes," add "and trailers as defined by Section 9.31e and in accordance with the following standards:


1. The semi-trailer units can not be parked closer than 100 feet to the property line of the commercially zoned property which abuts property within zones A-1 through A-10.
2. Semi-trailer units may be parked upon the premises for special events, and can not encroach into the public right-of-way. Each parking period shall not exceed five (5) days and each business shall be permitted no more than four (4) periods per year.
3. A permit issued by the Permit Department shall be charged for each separate period in the amount of twenty-five dollars (\$25.00)."

In Part 9. Definitions, add the following:

"9.31e Trailer-semi: A freight trailer that when attached, is supported at its forward end by the fifth wheel device of the truck tractor."


