8 **ORDINANCE NO. 2516**

11 An ordinance amending Ordinance No. 2468 to provide for the unclassified  
12 position of Community Development Administrator as an Assistant to the Mayor.  
13

14 WHEREAS, the City Administration is proposing a new unclassified position  
15 known as the Community Development Administrator; and  
16

17  
18 WHEREAS, said position will provide professional administrative work in the  
19 overall administration of the HUD Community Development Block Grant (CDBG) program,  
20 grants, the Olde Towne Tax Incremental Corp., and shall further serve as the  
21 development facilitator for new businesses; and

24 WHEREAS, the Administration is recommending a position grade of ninety-  
25 two (92), which has a minimum salary of twenty-two thousand dollars (\$22,000), a mid-  
26 range salary of twenty-seven thousand dollars (\$27,000), and a maximum salary of thirty-  
27 five thousand dollars (\$35,000); and

30 WHEREAS, the Airport Manager and Cultural Affairs Director are currently  
31 classified as grade ninety-two (92).  
32

34 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it  
35 does hereby amend Ordinance No. 2468, the Unclassified Pay Plan to provide for the  
36 position of Community Development Administrator as an Assistant to the Mayor with a  
37 salary grade of ninety-two (92).



42 dollars (\$27,000) as adopted and approved in the 1993-94 Budget for the City of Slidell.


