11 An ordinance establishing a Capital Improvement Program for the City of  
12 Slidell with proceeds received from the St. Tammany Parish Public Trust Authority.

14 WHEREAS, on November 23, 1993, the City of Slidell has on deposit two  
15 million two hundred two thousand, seven hundred twenty-six dollars (\$2,202,726.00), plus  
16 accrued interest received from the St. Tammany Parish Public Trust Authority; and

19 WHEREAS, one hundred twenty-five thousand dollars (\$125,000.00) and  
20 six hundred sixty-four thousand one hundred sixty-four dollars (\$664,164.00) of said  
21 Public Trust funds have previously been approved for the acquisition of the South Savings  
22 building and the Senior Citizens facility, respectively.

28 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it  
29 does hereby establish a Capital Improvement Program with the remaining two million two  
30 hundred two thousand, seven hundred twenty-six dollars (\$2,202,726.00) of St. Tammany  
31 Parish Public Trust Authority proceeds as follows:


7 BE IT FURTHER ORDAINED that the City of Slidell shall seek assistance


