10 An ordinance rezoning properties known as 2859, 2861, and 2863 Palm
11 Drive from M-2 Light Industrial to A-7 Multi-Family Urban zoning designation as petitioned
12 by Madeline O. Sciacca.

14 WHEREAS, the Slidell City Council has received a petition from Madeline
15 O. Sciacca to rezone properties known as 2859, 2861, and 2863 Palm Drive from M-2
16 to A-7; and

17
18 WHEREAS, said properties face Palm Drive and is near the corner of the
19 street entrance to the Bayou Shadows Condominiums; and

20
21 WHEREAS, the Slidell Planning and Zoning Commission has issued a
22 favorable recommendation for said rezonings.

24 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the
25 following described parcels of land be rezoned from M-2 Light Industrial to A-7 Multi-
26 Family Urban zoning designation as petitioned by Madeline O. Sciacca:



29 These properties are situated in Section 44, Township 9 South, Range 14 East,
30 City of Slidell, St. Tammany Parish, Louisiana, and more described as:



32 Being the west portion of Parcel 1, said property commences at the corner
33 common to Sections 15, 16, 21, and 22 of said township and range to North 25
34 degrees, 12'35" West 3,454.72' to a point on the westerly edge of Palm Drive
35 thence North 26 degrees 37' East along said westerly edge of Palm a distance of
36 1, 129.0' to an iron and the point of beginning. Thence go North 63 degrees 23'
37 West a distance of 103.30 feet to an iron, thence North 26 degrees 37' east
38 a distance of 69.45' to an iron set. Thence South 65 degrees 17'06" east a distance
39 of 103.4' to an iron. Thence South 26 degrees 37' West a distance of 72.88 to the
40 point of beginning.
