8 **ORDINANCE NO. 2542**

10 An ordinance rezoning properties known as 2853, 2855, and 2857 Palm  
11 Drive from M-2 Light Industrial to A-7 Multi-Family Urban zoning designation as petitioned  
12 by Thomas V. Sciacca.

13  
14 WHEREAS, the Slidell City Council has received a petition from Thomas V.  
15 Sciacca to rezone properties known as 2853, 2855, and 2857 Palm Drive from M-2 to  
16 A-7; and

19 WHEREAS, said properties face Palm Drive and are on the corner of the  
20 street entrance to the Bayou Shadows Condominiums; and

23 WHEREAS, the Slidell Planning and Zoning Commission has issued a  
24 favorable recommendation for said rezonings.

27 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the  
28 following described parcels of land be rezoned from M-2 Light Industrial to A-7 Multi-  
29 Family Urban zoning designation as petitioned by Thomas V. Sciacca:

33 These properties are situated in Section 44, Township 9 South, Range 14 East,  
34 City of Slidell, St. Tammany Parish, Louisiana, and more fully described as:

37 Commencing at corner common to Sections 15, 16, 21, and 22 of said Township  
38 and Range, go North 25 degrees, 12 minutes 36 seconds West, a distance of  
39 3545.72 feet to a point; thence go North 26 degrees, thirty-seven minutes East, a  
40 distance of 1201.88 feet to an iron and the point of beginning; thence go North 65  
41 degrees, seventeen minutes, .06 seconds West, a distance of 103.4 feet to an  
42 iron; thence go North 26 degrees thirty-seven minutes East, a distance of 78.79  
43 feet to an iron; thence go South 63 degrees 23 minutes East, a distance of 103.30  
44 feet to an iron; thence go South 26 degrees 37 minutes West, a distance of 75.36  
45 feet to the point of beginning.




