Beginning at the intersection of the edge of section 5 and the eastern edge of the street right of way for St. Christopher Drive proceed 779.79 feet southward along the eastern edge of the street right of way to the southwest corner of lot 76 (point of beginning), thence 198.24 feet south 81 degrees east, thence 100.19 feet south 5 degrees, 25 minutes, 45 seconds west, thence 204.48 feet north 81 degrees west, thence 100 feet north 9 degrees east to the point of beginning.
