7 **ORDINANCE NO. 2744**

9 An ordinance for the City of Slidell which shall set forth and designate the
10 adjusted millage rates as required by Paragraph B of Section 23, Article VII of the
11 Constitution of Louisiana, for the purpose of maintenance and operation of the Police
12 Department, Garbage Collection, Sewer System, Public Works, General Government, as
13 well as providing for the payment of interest and principal on outstanding general obligation
14 bonds, in said City for the fiscal year 1998.

16 SECTION 1. BE IT ORDAINED by the Slidell City Council of the City of
17 Slidell, Louisiana, in legal session convened, that there is hereby levied an aggregate tax
18 of thirty-seven and four one hundredths (37.04) mills on the dollar upon all property
19 taxable, under the laws of the State of Louisiana, situated in said City, according to the
20 assessment roll of said City in the calendar year 1997.

21 SECTION 2. BE IT FURTHER ORDAINED that said aggregate tax is
22 composed of the following individual authorized tax levys: a tax of 6.18 mills for the
23 purpose of raising and providing sufficient revenues to pay and defray the expenses of the
24 municipal government and for the general municipal and local purposes in the City of
25 Slidell, Louisiana, for the year 1998, as shown by the budget for the year 1998, adopted
26 by the City Council of said City. So authorized by Louisiana Constitution Article VI, Section
27 27 at 6.18 mills.

28 A tax of 3.0 mills for the purpose of maintenance and operation of the Municipal
29 Police Department in the City of Slidell, Louisiana, for the year 1998. So authorized by the
30 special taxpayer election held in the City of Slidell, Louisiana, November 8, 1984.

31 A tax of 2.53 mills for the purpose of maintenance and operation of the Municipal
32 Police Department in the City of Slidell, Louisiana, for the year 1998. So authorized by the
33 special taxpayer election held in the City of Slidell, Louisiana, April 4, 1981.

34 A tax of 5.0 mills for the purpose of garbage disposal and maintenance in the City
35 of Slidell, Louisiana, for the year 1997. So authorized by the special taxpayer election
36 held in the City of Slidell, Louisiana, November 8, 1994.

5 A tax of 5.0 mills for the purpose of maintenance of the sewerage system of the City
6 of Slidell, Louisiana, for the year 1998. So authorized by the special taxpayer election held
7 in the City of Slidell, Louisiana, November 8, 1994.

8 A tax of 2.53 mills for the purpose of maintaining, operating, and improving public
9 works within the City of Slidell, Louisiana, for the year 1998. So authorized by the special
10 taxpayer election held in the City of Slidell, Louisiana, April 4, 1981.

11 A tax of 2.57 mills for the purpose of providing an amount sufficient to pay interest
12 and maturing bonds for the 1989 Water Bonds Series A, and 1989 Sewer Bonds Series
13 B, and the 1989 Refunding Bonds Series C of the City of Slidell, Louisiana, for the year
14 1998, as authorized by a special taxpayers election held November 8, 1988, and by a
15 Resolution of the Mayor and the Councilmen of the City of Slidell, Louisiana, passed on
16 the 24th day of January 1989.

17 A tax of 2.62 mills for the purpose of providing an amount sufficient to pay
18 interest and maturing bonds for the 1994 General Obligation Refunding Bonds of the City
19 of Slidell, Louisiana, for the year 1998, as authorized by a special election held November
20 8, 1988, and by a Resolution of the Mayor and the Council Members of the City of Slidell,
21 Louisiana, passed on the 8th day of March, 1994.

22 A tax of 7.61 mills for the purpose of providing an amount sufficient to pay
23 interest and maturing bonds for the 1996 General Obligation Bonds for the City of Slidell,
24 Louisiana, for the year 1998, as authorized by a special election held November 18, 1995,
25 and by a Resolution of the Mayor and the Council Members of the City of Slidell, Louisiana,
26 passed on the 12th day of September, 1995.




