9 An ordinance annexing and zoning a portion of Lot 4, Square 25, Pearl Acres
10 Subdivision, from Parish C-2 Highway Commercial to City C-4 Highway Commercial zoning
11 designation as petitioned by Dr. and Mrs. Michael Edwards.

13 WHEREAS, the Slidell City Council has received a petition from Dr. and Mrs.
14 Michael Edwards to annex and zone a portion of Lot 4, Square 25, Pearl Acres
15 Subdivision, Section 6, Township 9 South, Range 15 East, Greensburg Land District, St.
16 Tammany Parish, Louisiana; and

17 WHEREAS, said property is located on the South side of Gause Boulevard,
18 East of Pearl Acres Street.

19 WHEREAS, the Slidell Planning and Zoning Commission has issued a
20 favorable recommendation for said annexation and zoning.


21 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the
22 following described parcel of land be annexed into the corporate limits of the City of Slidell
23 into Councilmanic District E and zoned C-4 Highway Commercial, and more fully described
24 as follows:


25 Commencing at the Western corner common to Lot 3 and Lot 4, measure
26 East a distance of 53.00 feet to an iron post, which iron post is the point of
27 beginning, thence measure North a distance of 122.80 feet, to an iron post,
28 thence West a distance of 53.00 feet to an iron post, thence continue North
29 along the East right-of-way line of Pearl Street a distance of 203.71 feet to
30 an iron post, thence on a diagonal line at the intersection of Pearl Street and
31 Gause Boulevard East, a distance of 25.75 feet to an iron post, thence along
32 the southerly right-of-way line of Gause Boulevard, a distance of 95.43 feet
33 to an iron post, thence South 378.16 feet to an iron post, thence West 53.00
34 feet to the point of beginning.
