6 **ORDINANCE NO. 2953**

8 An ordinance adopting and enacting a new Code for the City of Slidell,
9 Louisiana; providing a penalty for the violation thereof; providing for the manner of
10 amending such Code; and providing when such Code and this ordinance shall become
11 effective.

12 BE IT ORDAINED BY THE SLIDELL CITY COUNCIL:

13 Section 1. The Code entitled "Code of Ordinances, City of Slidell, Louisiana,"
14 published by Municipal Code Corporation, consisting of chapters 1 through 29, each
15 inclusive, is adopted.

18 Section 2. All ordinances enacted on or before September 28, 1999, and not
19 included in the Code or recognized and continued in force by reference therein, shall
20 remain in full force and effect.



23 Section 3. Unless another penalty is expressly provided, every person convicted
24 of a violation of any provision of the Code shall be punished by a fine not exceeding
25 Five Hundred Dollars (\$500.00) or imprisonment for a term not exceeding six (6)
26 months, or by both such fine and imprisonment. Each act of violation and each day
27 upon which any such violation shall occur shall constitute a separate offense. The
28 penalty provided by this section, unless another penalty is expressly provided, shall
29 apply to the amendment of any Code section, whether or not such penalty is reenacted
30 in the amendatory ordinance. In addition to the penalty prescribed above, the City may
31 pursue other remedies such as abatement of nuisances, injunctive relief and
32 revocation of licenses or permits.

35 Section 4. Additions or amendments to the Code when passed in such form as
36 to indicate the intention of the City Council to make the same a part of the Code shall
37 be deemed to be incorporated in the Code, so that reference to the Code includes the
38 additions and amendments.

41 Section 5. Ordinances adopted after September 28, 1999, that amend or refer to
42 ordinances that have been codified in the Code shall be construed as if they amend or
43 refer to like provisions of the Code.


