5 **ORDINANCE NO. 2954**

6 An ordinance annexing and zoning approximately .91 acres of land
7 located on Highway 190 (Shortcut Highway), from Parish C-2 Highway Commercial to
8 City C-4 Highway Commercial zoning designation, as petitioned by Guy and Georgia
9 Helmer.
10

11 WHEREAS, the Slidell City Council has received a petition from Guy and
12 Georgia Helmer to annex and zone approximately .91 acres of land from Parish C-2
13 Highway Commercial to City C-4 Highway Commercial zoning designation; and
14

15 WHEREAS, said property is located at Highway 190 and Fremaux; and
16

17 WHEREAS, the Slidell Planning and Zoning Commission has issued a
18 favorable recommendation for said annexation and zoning.
19

20 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the
21 following described parcel of land be annexed into the corporate limits of the City of
22 Slidell into Councilmanic District C and zoned C-4 Highway Commercial, and more
23 fully described as follows:
24

25 A certain piece or portion of ground, situated in Section 11, T-9-S, R-14-E,
26 St. Tammany Parish, Louisiana and more fully described as follows:
27 From the Northeast corner of Section 11, T-9-S, R-14-E, St. Tammany
28 Parish, Louisiana, go south 89 degrees, 52 minutes west 3175.92 feet;
29 thence south 2640 feet; thence south 89 degrees 52 minutes west 531.0
30 feet; thence south 110.0 feet to the point of beginning. From the point of
31 beginning, go north 89 degrees 52 minutes east 254.0 feet; thence south
32 30 degrees 21 minutes 52 seconds west 286.9 feet to a point located on
33 Highway 190 (Shortcut Road); thence go northwesterly along the northern
34 right-of-way line of Highway 190 (Shortcut Road) a line of Highway 190,
35 go north 03 degrees 34 minutes 54 seconds west 175.3 feet back to the
36 point of beginning. Said property contains 0.91 acres (39,485 sq. feet)
37 more or less.






