An ordinance annexing and zoning 22.7767 acres of land from Parish M-1 Light Industrial and A-6 General Multiple Family to City M-2 Light Industrial and A-8 High Density Urban designation, as petitioned by Brian Reine, Discovery Development.

WHEREAS, the Slidell City Council has received a petition from Brian Reine, Discovery Development, to annex and zone 22.7767 acres of land from Parish M-1 Light Industrial and A-6 General Multiple Family to City M-2 Light Industrial and A-8 High Density Urban designation; and

WHEREAS, said property is located on Howze Beach Road, off Old Spanish Trail; and

WHEREAS, the Slidell Planning and Zoning Commission has issued a favorable recommendation for said annexation and zoning with the following conditions:

- 1. That a minimum fifty (50) foot no build/no clearance buffer be provided along Howze Beach Road.
- 2. That all access is provided to the property from Joseph Street and no access be provided from Howze Beach Road.
