ORDINANCE NO. 2970

An ordinance rezoning 4.1597 acres of land located on the north side of Old Spanish Trail between Adam Street and Rama Street, from C-2 Neighborhood Commercial to C-4 Highway Commercial designation as petitioned by Ralph Kastner, Sr., Kastner Enterprises, Inc.

WHEREAS, the Slidell City Council has received a petition from Ralph Kastner, Sr., Kastner Enterprises, Inc., to rezone 4.1597 acres of land from C-2 Neighborhood Commercial to C-4 Highway Commercial; and

WHEREAS, said property is located on the north side of Old Spanish Trail between Adam Street and Rama Street; and

WHEREAS, the Slidell Planning and Zoning Commission has issued a favorable recommendation for said annexation and zoning.

NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the following described parcel of land be annexed into the corporate limits of the City of Slidell into Councilmanic District A and zoned C-4 Highway Commercial, and more fully described as follows:
