10 BE IT ORDAINED by the Slidell City Council of the Parish of St.  
11 Tammany, Louisiana, in a public hearing held on November 28, 2000, which hearing  
12 was conducted in accordance with the open meetings law and the additional  
13 requirements of Article VII, Section 23(C) of the Constitution, that the following  
14 adjusted millage rate(s) be and they are hereby levied upon the dollar of the assessed  
15 valuation of all property subject to ad valorem taxation within said Parish for the tax  
16 year 2000 for the purpose of raising revenue:




